Subject:- Grant of recognition beyond 30.4.1978.

Sir,

With reference to the correspondence resting with your letter No.Rs/RKP/F.Recog/115 dated 17.10.1978 on the subject cited above, I am directed to inform you that the Director of Education, Delhi has been pleased to grant recognition of Ramjas School, Sector IV, R.K.Puram, New Delhi as a Secondary school (Classes I to X) without grant-in-aid for the period from 1-5-1978 to 30-4-1980 subject to the fulfilment of the following conditions:-

1. That a sum of Rs.4000/- may be spent for the equipment of Laboratory and Workshop during 1978-79 and another sum of Rs.4000/- during 1979-80. Compliance report may be sent by 30.3.1979.
2. That a sum of Rs.4000/- may be spent for the purchase of library books during 1978-79 and another sum of Rs.4000/- during 1979-80. Compliance report may be sent to this effect at an early date.
3. The unqualified teachers/other employees shall acquire the requisite qualifications within a period of three years failing which the services of unqualified teachers/Employees be dispensed with.
4. The teachers and other employees who were appointed after 31-12-1975 and were overage at the time of appointment may be replaced by others possessing the requisite qualifications and age limit prescribed for the posts. A list of such employees may be submitted by 30.12.1978 with full particulars.
5. The teachers and other employees who were appointed before 31-12-1975 and were overage at the time of appointment, their full particulars may be sent to this office for seeking relaxation in their cases. The particulars of such teachers may be submitted on the following proforma:-

6. The services of any employee who is being retained after attaining the age of superannuation may be dispensed with immediate

7. The school authorities shall not, in future, employ any unqualified or overage staff and any violation of this conditions would result in withdrawal of recognition of the school.

8. The school will follow the provisions of the Delhi School Education Act 1973 and rules framed thereunder and other instructions issued by the Department from time to time.

9. The requisite number of teachers(all categories/employees) may be appointed as per norms of the Department.

It is also informed that an inspection of the school will be conducted shortly to ascertain whether the above directions and other provisions of the Delhi School Education Act and Rules are being complied with or not to decide whether the recognition granted should be allowed to continue or should be withdrawn.
