Subject: - Upgradation of the school to + 2 stage.

Sir,

With reference to the correspondence resting with your letter No. RS/RKP/MBP dated 6.3.1980 on the subject cited above, I am to convey the approval of the Director of Education, Delhi for upgradation of Ramjas School, Sector IV, R.K. Puram, New Delhi to + 2 stage (Sr. Sec. School) in all the three Streams i.e. Science, Commerce and Humanities with permission to introduce class II w.e.f. 1.5.1980 subject to the fulfilment of the following conditions

1. The Management of the school will spend an amount of Rs. 50,000/- for the purchase of furniture during 1980-81. Another amount of Rs. 30,000/- will also be spent for the purchase of furniture during 1981-82.
2. A sum of Rs. 25,000/- will be spent for the purchase of Science equipments during 1980-81. Another sum of Rs. 25,000/- will also be spent for the purchase of Science equipments during 1981-82.
3. A sum of Rs. 15,000/- will be spent for the purchase of library books during 1980-81. Another amount of Rs. 15,000/- will also be spent for the purchase of library books during 1981-82.
4. An amount of Rs. 10,000/- will be spent for the purchase of apparatus, I.V. materials etc. during 1980-81 and equal amount of Rs. 10,000/- during 1981-82.
5. The required number of Teachers and P.G.Ts will be appointed immediately. The P.G.Ts are to be appointed subject-wise.
6. No unqualified/overaged teacher will be appointed.
7. The Management will follow the provisions of Delhi School Education Act, 1973 and Rules framed thereunder and other instructions of the Department issued from time to time.

The compliance report for the appointment of P.G.Ts subject-wise may be submitted to this office by 31.8.1980.

The compliance report of the expenditure to be incurred during 1980-81 may be sent to this office by 31.12.1980 and compliance report of the amounts to be spent during 1981-82 may be submitted to this office by 31.12.1981.
